Why?	Financial companies choose how they share your personal information. Federal law gives you the right to limit some, but not all, sharing. Federal law also requires us to tell you how we collect, share, and protect your information.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: • Social Security Number (SSN) or Employee Identification Number (EIN) • Financial Information such as sales or revenue • Transaction activity

Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. • <i>Our affiliates include companies under the ownership of Green Check Verified, Inc.</i>
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. • <i>Non Affiliates we share with can include financial institutions, insurance companies, data processors, software companies, collection agencies, credit bureaus, marketing service providers, and state and federal government agencies.</i>
Joint Marketing	A formal agreement between non affiliated financial companies that together market financial products or services to you. • <i>We may partner with non affiliated financial companies to jointly market financial products or services to you</i>
